Objectives and Investment Policy

Investment Objective and Policy

The investment objective of the Fund is to produce capital growth over the long term. This is a geographically specific fund, which invests primarily across the Pacific Rim but also in the wider emerging markets, with a focus on companies that are judged to be innovators or are beneficiaries of innovation through their products, services or business models.

The Fund will invest at least 60% of scheme property, directly or indirectly, in equities. The Fund may also invest in fixed income, eligible alternatives and other transferable securities, money market instruments, deposits, cash and near cash. Exposure to these asset classes may be gained through direct investment and through investment trusts and collective investment schemes (including those managed or operated by the ACD), including exchange traded funds. No more than 10% of the Scheme Property of the Fund will consist of units or shares in other collective investment schemes. Derivatives may be used for both investment purposes and Efficient Portfolio Management.

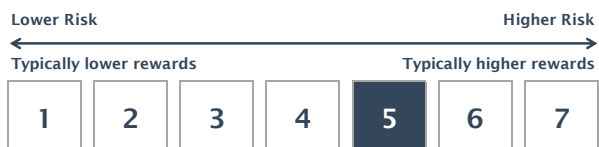
The Fund uses the Morgan Stanley Capital International (MSCI) Asia Pacific Index NR (GBP) for performance comparison purposes only and the benchmark is not a target benchmark and the Fund is not constrained by it. The index has been selected as a benchmark for performance because the constituents are representative of the areas in which the Fund itself is likely to invest, and it is therefore an appropriate comparator for the

The ACD reserves the right to change the Reference Benchmark following consultation with the Depositary and in accordance with the rules in COLL. The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of simulated data which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology. The simulated data used is consistent with risk limits of the Fund.

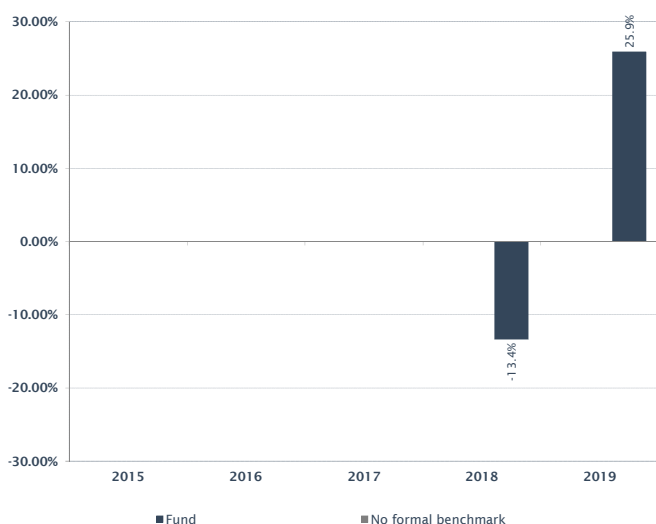
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
